# 1. About Unity Field Mapping


The Smarter Drafter Pro integration with Unity Practice Management allows you to:

- 1. Use Unity contact data when filling in Smarter Drafter Pro forms.
- 2. Send documents generated with Smarter Drafter Pro to matters in Unity.
- 3. Map Unity matter and contact fields to Smarter Drafter Pro forms fields so that data can be pulled into Smarter Drafter when filling in forms.

# 2. Enabling the Unity Integration

To enable the Unity Practice Management integration with Smarter Drafter Pro, head to the navigation menu on the left and click:

- 1. Account.
- 2. General.
- 3. Integrations.
- 4. Click Unity Practice Management to expand:
  - a. Enter your Unity instance URL.
  - b. Click Enable.





5. A pop up will appear prompting you to enter your Unity username and password to authenticate and grant Smarter Drafter Pro access.

6. Once the integration is connected successfully, you will see your Unity contacts in Smarter Drafter Pro under Account > Contacts.

**Note:** Unity contact data <u>cannot</u> be edited from Smarter Drafter Pro. The integration only allows for Smarter Drafter to pull the data from Unity to use when filling in forms. Unity will remain the source of truth.



# 3. Accessing Unity Contacts to Fill in Forms

When the integration is enabled, Form Fillers will be able to use Unity contact data to fill out Smarter Draft forms. By typing the contacts name into the name field on a form, a dropdown will appear with all the available contacts. Upon selecting the contact, their details saved in Unity will be mapped to the corresponding fields in Smarter Drafter automatically.

# 4. Mapping Unity Fields to Field Aliases

In addition to syncing contacts, the Unity integration with Smarter Drafter Pro allows fields from matter and contact objects in Unity to be mapped to Smarter Drafter field aliases.

#### 4.1 Field Aliases

Field Aliases are generic identifiers that are used to create a connection between fields across forms. This allows data to be shared from one form to another when the same field alias is used on both (or many) forms.

Helpful Tip: Come up with a standardised naming convention when creating field aliases that can be used across various forms, which creates the necessary connection for sharing data from one form to another.

#### 4.2 Importing Unity Fields

To import matter and contact object fields from Unity into Smarter Drafter Pro, navigate to:

- 1. Application Settings.
- 2. Field Aliases.
- 3. PMS Mapping.
- 4. Click Connect Unity Practice Management.

#### 4.3 Mapping to Field Aliases

To map a Unity field to a Smarter Drafter Pro field alias, click + New Mapping. A pop-up will appear allowing you to select an alias and click Save.

**Important note**: A field alias can only be mapped to *one* Unity field per object **i.e.** a field alias can be mapped to one *matter* object field and one *contact* object field.



#### 4.3.1 Compatible Field Aliases and Data Types

Field Aliases must be mapped to field aliases with compatible data types.

Date Type	Compatible Field Aliases
String	text, textarea, name, phone, email, id
Boolean	checkbox, radio, select
Currency	number
Date / DateTime	datetime
ld	text, textarea, name, phone, email, id
Text Area	text, textarea, name, phone, email, id
Phone	text, textarea, name, phone, email, id
URL	unsupported
Email	text, textarea, name, phone, email, id
Pick List*	checkbox, radio, select
Multi Pick List*	checkbox, radio, select
Address	address

**Important note:** When mapping "Pick List" and "Multi Pick List" data types to a field alias, the corresponding form fields *must* have the same options with the exact label and order number. If not, the data will not be populated in the Smarter Drafter form.



## 5. Auto-Filling Forms from Mapped Fields

Once the field aliases are mapped, Form Fillers can import data from Unity to auto-populate form fields in Smarter Drafter. To do so:

- 1. Click Forms > Fill from the navigation menu.
- 2. Locate the form.
- 3. Click Start Form.

A pop-up will appear to select the matter to import data from.

- 1. Ensure the Matter source is set to "Unity Practice Management",
- 2. Select the matter:
  - a. If the matter is not displaying in the dropdown list, click **Import from Unity Practice Management** to import new matters, and
- 3. Click Start Form

### 6. Send Document to Unity

Upon completing the form, a pop-up will appear asking to send the generated document directly to the Unity matter selected at the start of the process (step 5 from Section 5). Click Yes and the document will be sent once it has been generated.
