How it works

Kevin (Kev) has a successful chain of stores selling hardware tools and kitchen utensils called Hammer and Tong. Kev is opening a brand new store in Geelong and needs to hire a variety of new staff members to run its day to day operations.

After a number of interviews, Kev finds 3 new employees who he thinks will make a great addition to the Hammer and Tong family.

Julie White, an eccentric ex pub owner, will be coming onboard as the full time store manager. James (Jimmy) Daniels and his twin sister Michelle will take on the roles of casual sales assistants while they finish their university degrees.

Kev instructs you to draft the employment contracts for all 3 employees and wishes to include the following instructions:

Important Considerations

Approach #1

You can document this loan as a Loan Agreement with a fixed amount that is advanced by Kevin in one sum and payable on demand with interest only monthly repayments to be paid in arrears.

Approach #2

You can document this loan as a Loan Facility Agreement that is a fixed amount to be drawn down by Tasty Toasties Pty Ltd by a certain date or over a certain time period. Amounts drawn down can be fixed at a minimum amount for each drawdown.

The loan is interest only and is repaid on demand with payment of interest by monthly instalments payable in arrears.

Deed of Guarantee

In both approaches a Deed of Guarantee is given by Tom Smith as Guarantor of the obligations of Tasty Toasties Pty Ltd.
